It was resolved to adopt the policy.

97/19 To receive an update from the Local Council Forum

Cllr JM attended the West Northamptonshire Local Council Forum on 19th June where it was confirmed that West Northamptonshire Council (WNC) would be electing 93 members onto its shadow council and North Northamptonshire Council (NNC) would be electing 78 members on 7th May 2020 (town and parish council elections will be held on the same day). Wards are based on existing NCC divisions and there will be no review of existing boundaries.

The two new unitary councils will formally commence on 1st April 2021 ("vesting day"). This is a year later than originally proposed.

There will be one children's trust across the whole county providing services for children and young people. At SNC, cllr JM assumes that the community grant and new homes bonus grant will carry on for one extra year. There will be no changes to town/parish councils' statutory duties.

The document 'prospectus for change' was discussed. This sets out an integrated plan to deliver local government reform and transformation across the county. Leaders, senior members and officers from the eight existing Northamptonshire councils are involved in working on this. There are eight workstreams. 98/19 To accept a proposal for permanent dog signage

It was resolved that the clerk should purchase five plastic signs to be put up around the village. Action: CK

99/19 To submit HS2 community environment ideas and resolve to apply for funding

After consulting with the village, CK circulated a list of ideas totaling approximately £75,000.00. It was resolved to put an application together and apply to the community environment fund. CK and cllr SR will meet on Friday 19^{th} July to start the process. **Action: CK/SR**

100/19 To discuss ideas for celebrating and commemorating the 75th anniversary of VE Day on Friday 8th May 2020

Chairman CE advised that following on from June's meeting where it was resolved to make the village Green available to facilitate the sharing of picnics and celebrations, the clerk and cllr MB have contacted our insurers to discuss issues with them and CE has canvassed various groups and individuals in the village to discuss it further. Cllr CR suggested that CE hardens her ideas up and puts together a firm proposal for the meeting in September. CK will also circulate a 'save the date' village email and ask if anyone has any ideas they'd like to put forward.

- A Allotments (CR) as no further communication has been received regarding a communal plot, it was agreed to advertise the plot for rent as it is looking neglected. Cllr CR has tidied up the path by the wall. **Action: CK**

- **Village Hall (JPB)** There are a few website issues that are being dealt with.
- **E Website** (MB) noting to report.
- F Village Greens, planting and trees (CE) a request from ECC to scarify and seed the Green has been received and CE responded asking for a meeting to discuss further. It was agreed that we should include this as an item on September's agenda and to invite members from ECC along to the meeting.

- **H Hs2 & Highways (SB)** the next HS2 meeting is on Friday 19th July but unfortunately no-one is able to attend. CE will write to Esme about the recent road closure and diversions.
- I Local Government Reorganisation (JM) see item 97/19.
- **St. George's Church** cllr JM advised that the fete was well attended and raised £1441.00 towards Church funds.

102/19 Correspondence received

- The Police have written to Evenley speed watch thanking them and advising them that during their last planned time with the equipment (in May and July) they generated 129 Police warning letters. - Complaints have been received from residents and from further afield regarding a tank from 'Tanks a Lot' (that appears to be kept at Evenley Fields Farm) destructing roads and verges in Charlton Road. The Police have been informed and the clerk has written to Helen Howard (Northants Highways) who is taking it up with 'Tanks a Lot'. In order that this doesn't keep happening, it was agreed that the clerk should try to find out about the law surrounding this activity and to contact Greatworth Parish Council (to see if they have experienced similar problems). It will also be raised at the ward meeting. The clerk will contact Helen to see if she has any updates.
- Cllr JM circulated information about a photographic competition sponsored by Evenley Residents Association that will form part of this year's summer fete, encouraging photographers to submit recent photographs of the parish. The photos will then be used to decorate the village hall, the new café and shop and post office and the Red Lion.

103/19 Councillor questions

- Cllr CR raised concerns regarding footings work taking place at the bottom of Bicester Hill on land known as the Piggeries. The clerk will contact planning and highways to see if they can offer any insight. *Action: CK*
- Cllr CR advised that parts of Evenley have a lot of overgrown vegetation encroaching on footpaths, adding
 that owners should take responsibility for their own properties. It was agreed to have an item in the Autumn
 newsletter.
- Cllr CR advised that Highways have left metal cases on the side of the road off the A43 roundabout. The clerk
 will ask them to collect.

 Action: CK
- Cllr JM advised that delivery vehicles have been parking on the Green. It was agreed that we should draft a letter that can be circulated to residents of the Green who can attach it to the windscreen of said vehicles to make them aware of the rules. Also, should more wooden bollards be installed along the edge of the Green to avoid further erosion? This will form part of the September agenda.
